## January Monthly Meeting Report

Preceding our annual A.G.M., Paula Lloyd MFHT, of the Bromley Holistic Therapy Centre, kindly spoke to us about toxic free living (Pursue What's Pure), as far as essential oils & related products are concerned. These are ethically sourced, respecting and supporting communities, the earth, and our health.

Her interest began as a child when her father was ill and had bad eczema. By experimenting with different organically grown plants, food and oils he managed to cure his ailments, and was passionate about the subject.

Her mother helped in finding the best aromatherapy oils, and even a massage or spray to your own body can be so rewarding in health and mind. Companies such as doTERRA (YouTube), On Guard, Salon Essentials and VerAge, can be found on social media, and work closely with farmers who grow plants

organically - on herbicide and pesticide - free soil too.

It is so good to back good production and sustainable jobs. It has been found that you can 'buy' an 'Organic' certificate for a high price too, if it is of any advantage to a grower, so always be wary! Side effects on the human body (and animals too) and all sorts of minor irritations can be caused by everyday products that we buy, even though we and our immune systems usually adapt. Always try and read the ingredients, and teach our children to observe what is contained in our toothpaste, hand/body wash, shampoos, and laundry products, even if it says 'pure', as although every one of us is different, some of us are sensitive or allergic to the small amount of poisonous chemicals that we (and the earth, rivers, seas and air) can accept, day to day.

### **AGM Report 2021**

This took place on Zoom and 23 members participated.

### **Comments on Year-End Accounts**

A very unusual year with only three meetings in the hall, therefore a saving on hall rental. However, we did invest in a subscription to Zoom to allow unlimited time for meetings. There was a significant drop in our overall expenditure: as there were no fêtes or fairs during the year, there was no expenditure on stall rental, and there was no campaigning expenditure.

Our income, however, was significantly down with only three 'live' meetings before Lockdown, although we had very high attendance at these three meetings and extremely generous donations. The 'tea' profits for these months were also well above average.

Our subscription income held up well and with added donations covered our meeting costs. (The majority of people add a donation to their sub, ranging from £2 to £17). In 2018 and 2019 our donation income was boosted by donations in memory of Sylvia Priestley.

Our normal stall income was this year replaced by income from re-user items from Graham and plants sold by Anne and Bill. Unfortunately, the significant income from Bill's Open Gardens has come to an end, but leaves us with a healthy legacy.

## **Part Three**

**Bromley Open Space Strategy:** An official response from Bromley Friends of the Earth has been sent, but John Pavitt emphasised how important it was for people to make individual responses as the number of responses received seems to carry more weight than the weight of the arguments put forward. Respondents were encouraged to send a copy to Colin Brand (Director of Environment and Public Protection) as well. Diana reported she had followed the link to the Survey Monkey questionnaire and said that answers by this method were somewhat impersonal and she'd not been confident that the survey had gone through, but did subsequently receive confirmation that it had.

**Heathrow Airport:** The court had ruled that expansion (3<sup>rd</sup> runway) could go ahead. However, given the current economic climate and dramatic pull back from air travel and with airports running at a fraction of their normal capacity, it may be hoped that this may be stalled for quite some time, and then hopefully reviewed.

Friends of the Earth list **Heathrow** as an issue under the Climate campaign heading. Ann felt that, rather than just focussing on Heathrow, the campaign should be called **Airport Expansion** and cover all possible expansion, eg City Airport.

**Walks/Outings :** Sue and John tried the Farthing Downs Coulsdon walk (described by Rob in the December Newsletter) and further recommend



this. The Café at Bonnington Square keep sending out notifications; they were currently only offering takeaway but Sue suggested that, once restrictions are lifted and we are able to travel and mix freely again, we hold a celebratory meal there in their downstairs room. Something to look forward to! Please do email any ideas for walks (or future outings) to Sue and John.

**Planning:** Ann had sent in a further objection from us to development of the Maplin site, where a multi-storey building was proposed; this has now been reduced from 16 to 12 storeys, but is still massively out of keeping with the area and would have a detrimental effect on the character of the town. It would dominate the area, plus it would overlook the conservation area. The three Bromley Town Centre councillors are also opposed to this. Bromley Civic Society had produced graphics illustrating how the development would look.

Meetings will continue on Zoom for the foreseeable future. We are grateful to Rob for facilitating and co-ordinating these.

## Subscriptions

We have a button on our web page which allows people to pay a joining fee or renew their subscription to BFoE using paypal, the online payment method. Annoyingly, paypal charge us a hefty percentage for each transaction and so the usual £8 fee is eaten away by the time it hits our bank account.

Therefore we have agreed to increase the subscription amount when paying via paypal to £9 to cover these associated charges. The online messaging will reflect this.

## **Metal Farming (Agromining)**

It has been known for decades that certain plant species are capable of absorbing high concentrations of metals, probably to act as a defence against pests.

This is only possible in certain areas with soils that in the past have originated from deep down in the Earth's crust and pushed to the surface

by tectonic activity, with its content of metals and other rare earth elements.

In 1997, Rufus Chaney from the US Dept of Agriculture, demonstrated that certain plants could be harvested, and that nickel could be extracted.

More recently, a shrub has been found in Borneo that contains up to 25% by weight of nickel in its sap, and now this specific shrub is being used there to farm metal, yielding 250 kg of nickel a year per hectare, with a current value around \$4000.

(A hectare is about 1.5 football pitches, or the ground inside a 400 metre athletic track).

Agromining is now being tried nearer home. In Albania, where the soils are suitable, a plant is used that looks rather like kale. Yields are not as good as those in tropical Borneo, but still around 200kg of nickel per hectare, worth around \$3000, which could be a sustainable price. In the UK, a hectare of wheat sells for around \$2100.

This process also scores well environmentally. The plants take up CO2 which is released when burnt as part of the extraction process, but this is used to heat nearby buildings. So the process can be carbon neutral.

A team from the University of Lorraine have been assessing the use of a fern that grows naturally on the waste heaps from rare earth metal mines in China with the aim of harvesting around 300 kg of mixed rare earth metals per hectare.

Suitable soils can be quite poor quality for normal farming, and many farms on suitable land for agromining in Greece, Albania and Bulgaria are now being abandoned.

This technique will work with a range of metals, including the rare earth elements now in great demand for our essential everyday technologies.

## **Maplin High Street Site Objection**

Dear Planning Officer,

Bromley Friends of the Earth still wish to object to the proposal.

We are pleased to see the heritage frontage is to be maintained, that the height has been reduced to 12 storeys and the building moved further back from the High Street.

However, even at 12 storeys this is still far too high and seems very oppressive, setting a precedent for future new buildings in this part of the High Street, especially as the site is adjacent to a conservation area.

The design is still unimaginative, aesthetically unpleasing, and an extremely ugly design. It is also detrimental to the heritage of central Bromley.

Surely improvements could have been made to the design after our original objection. There is a feeling that costs dictate, but this is detrimental to the environment and the legacy we are leaving to future generations.

A number of younger people will also be having to live in another 'concrete monster'. Although this is a planning application by a private developer, can the LBB be proud of this type of design?

We think not, especially as the town centre ward councillors are opposed to it.

Where are the visionary architects and town planners that Bromley and our country so badly needs?

It is yet another example of Bromley's piecemeal development and lack of a co-ordinated planning strategy, where financial gain is paramount.

### **Fracking by Stealth**

Energy company Rathlin is drilling for oil and gas in the Yorkshire village of West Newton. The process is virtually the same as fracking, and the community's rural home is under threat.

For years, Rathlin Energy has been taking over the countryside surrounding the small village of West Newton. It's about to double operation and build two more oil wells.

## Open Space Strategy Letter

Dear Councillor William Huntington-Thresher

We are writing on behalf of Bromley Friends of the Earth. We have seen your recent press release and are so pleased that you have received over 800 responses to the Draft Open Space Strategy. It is a good indication of how the public value our open spaces. It will be very interesting to see the results of the analysis of the responses.

We have not seen any of the deliberately misleading comments on social media that you refer to. It is good to hear your confirmation that there is no intention to sell any park. It would be appreciated if you would also confirm that there is no intention to sell any other categories of open space. Other categories including woodlands, countryside, cemeteries, allotments, sportsgrounds, meadows, and a variety of simple green space, all of which is valuable to the community in its own way.

Certainly, a number of members of the public have been concerned about the meaning of some of the words used in

the Draft Open Space Strategy. It would be extremely helpful if you could clarify what is meant by terms such as reconfiguration, repurpose, alteration, reassignment, development, disposal etc. It would also be helpful to know where and why these actions will take place. It is possible that some of these terms may have been the reason for any misinterpretation. So clarification will be helpful.

As you are aware, Bromley Friends of the Earth have for many years been committed to working towards environmental improvements. Our group will be very pleased to work positively with you, the Council and Ideverde with the aim of promoting and enhancing the Borough's open spaces.

## **Climate**

### ***Global Experts Question UK's Climate Commitment***

Boris Johnson's government is investing only 12% of what is needed to tackle the climate emergency and the growing threat to nature, according to a new report which raises concerns about the UK's commitment to the green agenda.

The study says that ministers need to commit £33bn each year to green causes.

In 2021, the UK will chair the Glasgow COP26 climate change summit, and their initiatives will be influential. It is seen by Biden and other leaders as a critical test of the world's determination to limit global warming.

### ***Nuclear Energy***

it is estimated in an MP's report that nuclear sites will take 120 years to dismantle .

The cost will also be very high - decommissioning the UK's civil nuclear sites will cost generations of taxpayers £132 billion.

The Public Accounts Committee blamed a 'sorry saga' of failed contracts, 'weak' government oversight and 'perpetual' lack of knowledge of the state of nuclear sites. A clear break with the failures of the past is needed for the project to progress.

Meanwhile there is the ongoing problem of how past and present nuclear waste should be safely dealt with.

### ***Heathrow Expansion***

Heathrow has won the latest battle in its bid for a third runway. - but campaigners are vowing to pursue their challenge in Europe.

Supreme Court judges backed airport chiefs and the government , who say the expansion will allow global Britain to become a reality.

Environmental campaigners say they will launch a new appeal with the European Court of Human Rights. They are a mixture of groups including Greenpeace, Friends of the Earth and Plan B earth, and mayor Sadiq Khan.

On December 17th an earlier Court of Appeal ruling was overturned which said that the government had failed to take into account its own climate commitments and adhere to the Paris Agreement.

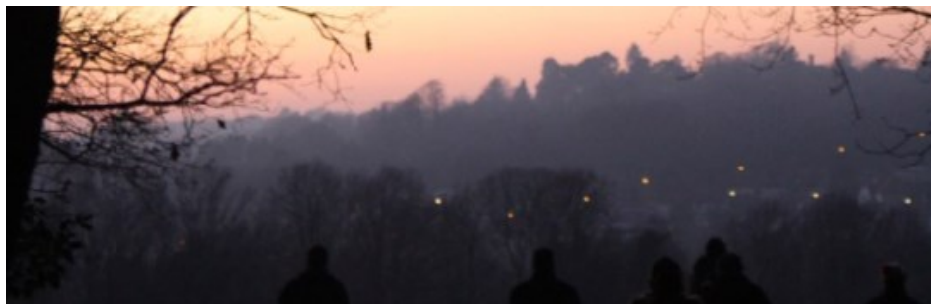
