April meeting report - from Anne Clark

Christopher Lloyd, journalist, lecturer, author and educationalist really did give us 4 Billion Years of Nature in 40 Minutes at our emergency venue in South St.

He explained that he wanted to capture youngsters' enthusiasm away from the 'bitty trench between science & history in the school curriculum'.

He donned a large coat with large pockets and delving into them one by one, we found clues which told a story. The Greeks used 'brain training to pass on knowledge, other than reading and writing.

In the first pocket was a bottle of WATER, said to have arrived on Earth via asteroids crashing into us and eventually forming 70% of world coverage. Another pocket produced a jar of air containing OXYGEN to form 'life': 35% of oxygen, years ago, brought huge life forms i.e. rats the size of donkeys, but when that dropped to 12%, a mass extinction occurred.

When no oxygen exists there would be a red sky. He went on to tell us about photosynthesis and 3.7bn years ago, bacteria were formed, producing food, and it massed together for protection, forming cells and nucleus. DNA reproduces for sexual reproduction in seas, to prevent extinction.

Delving in another pocket, he produced a FOSSIL or Trilobite of a woodlouse-like creature which evidently, could see and focus. Other life had genes & muscles and the instinct to survive.

FUNGUS was the first life form to emerge from the sea, 450 million years ago. Fish which don't rely on gravity had to form legs from fins, adopt neck bones and air breathing lungs to exist on land. Eggs were laid away from water so most had water inside a shell.

Some REPTILES including dinosaurs, were wiped out 65mn years ago, maybe as a result of an asteroid. PLANT life formed, flowers produced pollen to be collected by insects, fertilizing and becoming dominant. Dead trees formed coal, but none was formed during the mass extinction period due to lack of oxygen.

CHALK tells us of drifting continents and climate change. In the Ice age creatures adapted by forming more fat. A lack of trees urged apes to stand, use hands for making tools and for protection and hunting.

Volcanoes and super-volcanoes have periodically come and gone with self replicating genetic molecules which emerge near sulphur-rich hydrothermal vents made from organic chemicals that may have been brought by comets. So life could survive another mass extinction in the future though humankind must deplete in some way.

Christopher came up to date without pausing for breath but to explain things in more detail, he has produced books and an illustrated, giant wall chart - rather like the Bayeux tapestry, called "What on Earth" for young & old alike. Climate and Energy

RWE and E.on prepare to sell UK nuclear project

RWE and E.on said on March 29th that they would not proceed with their plans for reactors in South Wales and Gloucestershire. This basically leaves the government's energy plans in tatters. Unite and GMB unions are worried of course about jobs, but environmental groups have stated that nuclear power is not a viable option under the circumstances.

It was reported on April 9th, however, that RWE and E.on have kicked off plans to sell their UK nuclear plant joint venture. They have consulted lawyers, corporate advisers, and investment banks to come up with ideas as to how they can sell Horizon Nuclear Power.

An industry source has said that this is a seriously proper sales mandate

where the selected adviser will have to create bidders. Their proposed stations could cost more than £15 billion. Because of the complicated nature of the business, which still has to select the reactor designs, the sale process could stretch into 2013.

FoE energy campaigner Paul Steedman has commented: "With energy firms abandoning plans for nuclear across Europe, the government should end its fixation with a technology that has always delivered late, and over budget on the odd occasion it has delivered at all."

It's going to be a tough job for antinuclear campaigners nevertheless when faced with big business wheeling and dealing. The only hope in the end is that the new nuclear reactors will prove too expensive in this age of austerity.

Solar Power Generation

The Prime Minister has been accused of hypocrisy of hosting a major green energy conference and at the same time slashing subsidies for solar power generation.

The Third Clean Energy Ministerial conference, featuring more than 20 ministers from the world's leading economies will take place in late April. Although the High Court ruled last month it was unlawful to cut the a new feed- in tariff for solar power generation, anyone who generates electricity through solar power could only gain benefits till the end of March.

Figure It Out...

As ever, politicians twist a few words to suit their cause, and even the most exalted are guilty from time to time. Given that we have an airport in our territory – Biggin Hill – Bromley FoE keeps a watch on what is said about airport expansion, and we noticed this example of weasel words from George Osborne MP, chancellor of the exchequer.

In his budget speech he foreshadowed a change in government policy which previously was that there would never be a third runway at Heathrow, saying that 'we must confront the lack of airport capacity in the south east'. However, expert activists say that Gatwick is operating at 80 per cent capacity and Stansted at 50 per cent, and indeed, Gatwick is handing two million passengers less than five years ago.

Politicians are also spreading the myth that our airlines do not have the slots to allow them to serve expanding cities in countries like China. Not so, say Gatwick's well-respected conservation group, the slots are there and if there was enough business, airlines would have used them to meet demand.

Sustainable farming – email sent to the Minister for Agriculture

Graham Hemington recently sent this email to Jim Paice, Minister for Agriculture:

Dear Minister.

One year ago at Friends of the Earth's Sustainable Livestock Symposium, the Minister for Agriculture, Jim Paice, promised to take action to promote sustainable farming.

I am pleased to see some progress on research into soy alternatives for animal feed

I am however concerned at the lack of action in some key areas, like on reform of the Common Agricultural Policy (CAP), the use of food waste as animal feed, the promotion and education of sustainable diets and in helping farmers to sell direct to consumers.

An urgent priority is a CAP that helps farmers shift to planet friendly farming across Europe. With the CAP being debated now, DEFRA should be leading calls for green reforms.

Please can you ensure that DEFRA:

- Demands that all farmers receiving greening payments implement crop rotations with legumes
- Supports payments to increase the amount of home grown protein crops - reducing our dependence on imported soy
- Redirects payments from large farms to smaller farms and farms with high nature value
- Publishes a paper outlining its policies on the CAP reform that will shift the UK towards planetfriendly meat and dairy farming.

Visit to Hinkley Nuclear Power Station, Ms J Etter

The demo at Hinkley on March 10th was organised by the "Stop Nuclear Power Network" to mark the first anniversary on March 11th of the Fukushima disaster.

We boarded our coach at 7.30am at the Embankment and set off. It was a four hour journey, but seemed to ass quite quickly with info given out and passed round and conversation. Also we were given origami instructions on how to make a paper crane bird-of-peace.

We arrived at about 11.30am, the sun was out and it turned out to be a lovely day. We walked up the lane to join the others there; it transpired that there were around 1,000 people, the largest antinuclear power demo since 1979.

There were several speakers, including CND general secretary Kate Hudson, Green MP Caroline Lucas, environmentalist Jonathan Porritt and, importantly, Fukushima refugees. Akikoand Makoto Jahiyama described what it was like to live through the disaster. Citizens only had one hour, wearing anti-radiation suits, to go back with bin bags to salvage what they could of their possessions.

Unfortunately, the PA system was not working correctly, so unless you were quite near, you couldn't all that was said.

Also, there were complaints that there was no proper organisation, and people were unclear as to what was happening and when. Nevertheless, we knew we were going to surround the site where they intend to build Hinkley C, the first of a new generation of UK nuclear power stations. Well, we did this, put up banners and ribbons and signs and at a

given time made as much noise as possible, some with old saucepans and wooden spoons.

Although this was a serious message, there was a carnival atmosphere, with lots of people and children in fancy dress and colourful clothes. There was an eight piece jazz group who wandered about entertaining us with their songs and music and who were all dressed in garments of shocking pink, one guy had a black skirt, hairy legs and a pink boa!

There were stalls selling wonderful veggie food, so nice I took some home, and tea, coffee and soft drinks stalls, as well as a compost toilet if required.

There was a perfect though hilarious example of 'Green Energy' with a guy furiously pedalling a stationary bicycle, on the back of which was a juicer. His companion was making lovely drinks out of mangos, pineapples and bananas and selling them. This had the bonus of the rider benefitting from lots of exercise.

Some people were going to stay overnight to blockade the existing power station and took sleeping bags. The police were mostly friendly and laid back, they had an easy day just hanging around enjoying the sunshine, there was no trouble.

After walking around, chatting to various people, many of whom had come from nearby Glastonbury and Bristol and certainly did not relish a new 'neighbour' we the rejoined our coach at 5.30pm and were back at Embankment by 9.30pm, I got home around 11. A very eventful and successful day.

Questions re nuclear waste trains + Beckenham development

Nuclear Waste Trains Questions

The following questions were asked to Bromley Council Executive on April 11th by Richard Hart of Bromley and Beckenham CND and as a result they decided to ask for an updated risk assessment from Network Rail.

Question to the Executive

Since trains carrying Nuclear Waste continue to travel from Dungeness through stations in the London Borough of Bromley close to people's homes on their way to Sellafield, and in view of the decision by Newham Council to suspend trains through Stratford during the period of the Olympic Games, is Bromley Council convinced that no satisfactory assessment of the risk posed to Londoners by the trains has been carried out?

(Such a risk assessment was commissioned by the then Mayor of London in 2006, but its final report was not published because in Ken Livingstone's words "the assessment was not able to address the key issue of the risks from terrorist or other deliberate actions.")

Supplementary question

In view of this are Councillors not concerned that no satisfactory risk assessment of the dangers posed by the trains has been carried out and will you make recommendations to the Mayor of London and the GLA that such an assessment should be urgently carried out in view of the enhanced terrorist threat in London and if so what contingency plans do the Council have?

Beckenham development opposed

Bromley FoE has joined Beckenham residents in opposing a plan to sandwich three blocks of flats into a tight site behind the High Street – something that appears to be totally out of scale. The plan was rejected by Bromley Council after objections from residents and BFoE but the developer has gone to appeal. This was the note we sent to the planning inspector:

I have been requested by Bromley FoE to write to you to record our total opposition to the proposed development at High St, Beckenham.

This group has been in existence for 40 years and has considerable experience in planning matters in the London Borough of Bromley. We oppose this development primarily because it would be out of scale with surrounding sites. In particular, we draw attention to the height of the proposed buildings and the overdensity proposed (three four-storey blocks in a tight area of mainly two-storey buildings).

Such a development would produce a negative impact in the immediate area and reflect poorly on existing buildings. Insufficient car parking spaces would add to pressures already extant in the immediate area.

Please also take into consideration the risk of flooding and the potential impact on wildlife in the vicinity.

Overall, this site is important to maintaining some openness in what is already a busy and crowded suburb. Its loss would point the way to further decline.

Blast from the past - Co-ordinators Report for 1991

Recycling: we continued to run our regular can collection until November, when sadly the can crusher had to be returned to ACRA. I am not sure how many 'performances' Dan gave in 1991, but at least last year he was able to delegate a few of them and did a 'double act' at others - with Clare Birks at St. Olaves. (Quite a challenge as the audience was 90 sixth formers) and with Steve Davies at Bromley High School, to name but two. Thanks Dan, you do a great job and hopefully if we run a second Public Speaking workshop, you will get some more volunteer speakers for 1992.

Highlights: what else happened in 1991 - I suppose each of us will remember different things. But for me, one of the highlights has to be the visit to the Centre for Alternative Technology, organised by Mike Parish. It was an excellent weekend, thoroughly enjoyed by the 20 or so people who attended. Companies spend thousands of pounds sending their staff on team building courses. Mike managed to arrange one for us for around £.50 a head! Thanks Mike and we wish you and your family every success in your new venture at Corris in Wales. Bromley FoE will miss you. but we hope we will be able to arrange a trip to see you in 1992.

Bike to the Future: you either loved it or hated it. Either way it certainly was an event to remember and it did raise much needed funds for FoE at a UK level. Thanks to everyone who helped on the day - especially to Judy who badgered us all so hard to help in the first place. Let's hope Underwood Street will have heeded some of our comments for Bike to the Future 1992!

Days of Action: other important events have been the days of action. Two stick in my mind - the returnable bottles day in May and the Tropical Rainforest day in November. The former because this

FoE press releases on our energy system

More than four million households in debt to their energy supplier

Commenting on research by U-Switch today which shows over four million households are in debt to their energy suppliers, Friends of the Earth's Energy Campaigner Paul Steedman said:

"It's scandalous that energy companies are raking in huge profits while millions of us can't afford our fuel bills - it's time to end the big energy rip-off.

"Our dependence on expensive imported gas is the reason our bills are rocketing - it's not surprising that 70 per cent of us want the energy companies to develop clean British energy from our wind, sun and sea.

"The Government must wake up to the fact that renewable energy and energy saving are our best hope for affordable fuel bills in future - developing them will kick-start economic growth and create thousands of extra jobs in Britain."

Government papering over cracks of our broken energy system

Commenting on an announcement by Deputy Prime Minister Nick Clegg today (Wednesday 11 April 2012) that energy companies will be obliged to tell their customers about their best tariffs, Friends of the Earth's Energy Campaigner Paul Steedman said: "Clegg's admission that we can't control world energy prices points to the real problem for energy customers - that just six big energy firms have us hooked on dirty, expensive, imported gas.

"The Big Six's addiction to fossil fuels saw bills rise by up to 18 per cent last autumn - but despite this the Government wants to fuel their habit by building yet more gas-fired power stations.

"Rather than papering over the cracks of our broken energy system we need Ministers to make our homes more efficient and to switch to clean British energy from the wind, sun and waves we have in abundance."

Ministers have blamed the popularity of the feed-in tariff on their decision to cut the rate, insisting that it is too expensive to maintain.

Antarctic news

The British Scientific Research body [BAS] which discovered the hole in the ozone layer has had its research budget cut by 25%, which means its future work is seriously threatened. The Foreign Office, however, intend to contest the decision, which is good news, especially as the research is essential in monitoring the impact of climate change. A report is due out in the journal 'Polar Research' which will reveal that Britain's role in Antarctic science is unparalleled.

Friends of the Earth launches new campaign to Save the Bees

UK faces annual bill of £1.8 billion without bees - Friends of the Earth launches new campaign

It would cost the UK £1.8 billion every year to hand-pollinate crops without bees - 20% more than previously thought - according to new research launched today by Friends of the Earth as it unveils a new campaign to save the bee.

The new figure - equivalent to the annual wages of 60,000 teachers - comes from research conducted by leading bee experts at the University of Reading on behalf of the environment charity as it launches The Bee Cause to call for action on bees before it's too late

Friends of the Earth is also creating a temporary 150 square metre wildflower meadow in the shadow of the National Theatre, London, to highlight the need for more bee-friendly habitats - with the flowers used to create the spectacle given away to passers-by to encourage gardening that will help bees to thrive.

In recent years Britain has lost over half the honey bees kept in managed hives and wild honey bees are nearly extinct. Solitary bees are declining in more than half the areas they've been studied and some species of bumblebee have been lost altogether.

Costly hand-pollination is already being used in parts of the world, notably pear trees in Hanyuan County, China, where native bee populations have been wiped out by a combination of loss of their natural habitat and intensive farming.

Friends of the Earth is urging David Cameron to save these important pollinators and save the nation billions by committing to a British bee action plan. The plan outlines action on the planning of our towns, the way we farm and use pesticides and funding for nature experts in the Government to ensure vital bee populations are restored

The charity is also providing information and resources on how people can help bees in their gardens and communities, including giving away 20,000 packets of wildflower seeds.

Paul de Zylva, Nature Campaigner at Friends of the Earth said:

"Unless we halt the decline in British bees our farmers will have to rely on hand-pollination, sending food prices rocketing.

"Bees are responsible for most of our favourite fruit and vegetables so as well as the huge blow to our economy, our diet would also suffer.

"David Cameron must make the changes needed now to give our bees a fighting chance and save Britain billions."

WDM on the West Africa Food Crisis

I'm writing to you today because West Africa is experiencing a major food crisis. Millions of-people already face food shortages-throughout the-Sahel region. In Niger 5.5 million people are at risk, 3.5 million in Mali and 1.7 million in Burkina Faso.

This will be the region's fourth food crisis in eight years. Droughts, poor harvests and food price rises have all played a major part, but so have underlying structural causes.

Aid is essential in the short term, but will not help to prevent further crises in the future. Our reaction must go beyond aid and address the underlying political issues which have fuelled poverty and suffering in West Africa and throughout the world.

For decades the World Bank and IMF have been pushing 'structural adjustment' programmes on developing countries including those in the Sahel region. Countries have been forced to grow unconventional crops for export rather than producing food for local people and withdraw government support for food production.

The forced removal of border duties has led to local farmers being undercut and markets destroyed by cheap imports supported by rich governments' subsidies.

It is essential that we increase our campaigning on this key issue in light of the food crisis in West Africa and last year's crisis in the horn of Africa.

Increasingly liberalised markets have de-prioritised national food security and left African countries exposed to the volatility of the free market. To allow countries to prioritise food for their own people rather than distant export markets, Africa needs food sovereignty.

This is the simple principle of people being able to produce food to meet their own needs, in a way that is culturally and environmentally appropriate. It views food as a right rather than a commodity and rejects the corporate control of natural resources, which is aided by the IMF and World Bank.

Food sovereignty is a concept that originated in the developing world. It gives rich countries a chance to learn from the experience of developing countries, rather than dictating damaging, self interested policies to them. Food movements influenced by these principles have now emerged throughout the world, including Europe and the UK

The principles of food sovereignty were agreed by delegates from around the world at the Nyeleni conference in Mali in 2007. West Africa is a hub for food sovereignty activism and a region that could benefit hugely from being able to apply its principles.

Farmers and small scale producers globally are pioneering new techniques which are environmentally and economically sustainable so that they can feed themselves and sell any surplus they have.

Droughts and poor harvests will happen, but hunger has been exacerbated by the actions of the World Bank and the IMF, rich countries' governments and global corporations.

Food sovereignty will help countries determine their own path out of poverty and enable them to deal with issues like poor harvests as rich countries are already able to.

The movement for a fairer food system in the developing world is positive and hugely inspiring, but it needs global action to support it.
